IN FY 2015, TARRANT AREA FOOD BANK PROVIDED ACCESS TO 23.6 MILLION NUTRITIOUS MEALS THROUGH ITS NETWORK OF PARTNER AGENCIES, MOBILE SOLUTIONS, NUTRITION EDUCATION AND OUTREACH PROGRAMS.
